THIS AGREEMENT, entered into this date \_\_\_\_\_, by and between purchaser (First and Last Name) \_\_\_\_\_, and Adam Klaasmeyer of The Sedona String Quartet, City of Sedona, State of Arizona.

FOR AND IN CONSIDERATION of the mutual promises and benefits to be derived by the parties, they do hereby agree to the following: The SSQ is being hired as a string quartet to perform a three (3) hour musical performance for \$495. Additional performance time will be billed at \$165/hour at 30 min increments.

Terms: (1) A \$200 non-refundable deposit is required at the signing of this contract with the remainder of this agreement due on the performance date by check made payable to Adam Klaasmeyer.

(2) SSQ will arrive at the performance one hour prior to start time to set up. Attire will be formal black unless otherwise specified. Four straight-back chairs without arms will be provided for the musicians. SSQ will provide music stands. One 15 min intermission during performance for musicians is required.

(3) The Sedona String Quartet members consist of Adam Klaasmeyer, Kristina Beachell, Courtney Yeates and Rick Knous. SSQ will start at the time indicated in this contract and will provide 3 hour musical performance with the repertoire of music detailed in the included information.

(4) It is understood that some instruments, particularly string, are extremely valuable, and are susceptible to damage when exposed to certain climatic variations, such as rain, direct sunlight and temperatures below 60 degrees Fahrenheit. It is understood that performers must be provided with shelter from rain and direct sunlight and that the temperature must be at least 60 degrees Fahrenheit

(5) Additional travel fees will apply for performance locations outside a 25 mile radius of the city of Sedona, Arizona. Additional travel fees: \_\_\_\_\_

This instrument contains the entire agreement between the parties and may not be amended in any way except by agreement in writing and signed by both parties hereto. The waiver by either party to this Agreement of a breach of any term of this Agreement shall not operate or be construed as a waiver of any subsequent breach thereof.

If any one or more of the provisions of this Agreement shall be held unenforceable or invalid, the enforceability and validity of all other provisions of this Agreement shall not be affected thereby. This agreement is governed by the laws of the state of Arizona should any disagreement arise between the parties as it relates to employment, each party shall be responsible for their own attorneys' fees and court costs.
